

## ARTIST CONTRACT AGREEMENT

### ARTISTS' NETWORK OBLIGATIONS:

Artists' Network, at its own expense, will be responsible to provide Artist with the following services during the Term:

- Marketing virtual show through email and available social media platforms.
- Managing and maintaining the Leslie Grove Gallery and [lesliegrovegallerystore.ca](http://lesliegrovegallerystore.ca), including processing sales.

### ARTIST OBLIGATIONS:

- Accepted Artwork MUST be exclusively available for sale and NOT posted on another e-commerce website for the show's duration.
- Artist must drop off and pick up accepted artwork at the assigned day and time; otherwise, arrange an alternative date and time with Gallery in advance.
- Artist agrees to respond to all customer inquires received by the Leslie Grove Gallery store and arrange for the delivery and shipment of sold Artworks, at the cost of the Artist or buyer.

### POS SYSTEM

All sales will go through Leslie Grove Gallery or Leslie Grove Gallery online store and the Artists' Network will transfer the sales amount to Artist with a cheque. Discounting will be done by the amount of 20% of the transaction value for the commission fee. Artists' Network will charge HST on all pieces sold and will remit, on your behalf to the government.

### GENERAL

This Agreement is governed by and construed in accordance with the domestic laws of the province of Ontario, Canada and the laws of Canada applicable therein, without regard to conflicts of laws. The parties hereto hereby attorn to the exclusive jurisdiction of the courts of the province of Ontario. Neither party will assign its rights or obligations under this Agreement without the prior written consent of the other party. Any assignment without consent will be null and void. Superseding all prior oral or written communications with respect to the subject matter and the terms hereof, and may be altered, modified or changed only by a document signed by an authorized representative of each party.
